

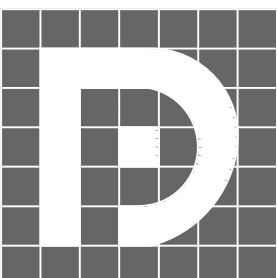


01 SPACE PLAN – THIRD FLOOR
